

# REGIONAL DISTRICT OF CENTRAL OKANAGAN

## BYLAW NO. 852

---

A bylaw to establish a local service within a portion of Electoral Area 'I' for the purpose of renovation, construction and ongoing operation for a community hall/fire hall on the Ellison Primary School site.

---

WHEREAS a Regional District may, by bylaw, establish and operate a local service under the provisions of Part 24 of the *Municipal Act*;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to establish a local service in a portion of Election Area 'I' for the purpose of renovation, construction, and operation for a community hall/fire hall on the Ellison Primary School site;

AND WHEREAS, in accordance with Section 807(2)(a)(i) of the Municipal Act, the Regional Board has received assent under Section 808;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN in open meeting assembled enacts as follows:

### 1. Service being established

- a) The service being established under this bylaw is a local service for recreation and other community use, pursuant to section 798(1)(f) of the *Municipal Act*.
- b) The local service for recreation and other community use being established under Section 1(a) is for the purpose of renovation, construction and operation for a community hall/fire hall facility on an existing site;

### 2. Service Area Boundaries

- a) The boundaries of the service area shall comprise that portion of Electoral Area 'I' outlined in Schedule 'A' attached to and forming part of this bylaw.
- b) The service area so defined shall be known as the "Electoral Area 'I' Ellison Heritage Community Centre Local Service Area".

**3. Participating Area**

The participating area for the service is that portion of Electoral Area 'I' outlined in Schedule 'A' attached to and forming part of this bylaw.

**4. Cost Recovery**

In accordance with Section 816(1) of the *Municipal Act*, the annual costs of providing the service shall be recovered by:

- a) The requisition of money under Section 823 to be collected by a property value tax to be levied and collected under Section 825, and
- b) the imposition of fees and other charges that may be fixed by separate bylaw for the purpose of recovering these costs.

**5. Requisition Limit**

The maximum amount of money that may be requisitioned annually under Section 816 (1)(a) of the *Municipal Act* for the service provided under Section 1 of this bylaw, shall not exceed \$0.53 per \$1000 of net taxable value of land and improvements for Regional Hospital purposes, within the service area.

**6. Citation**

This bylaw may be cited as "Regional District of Central Okanagan Electoral Area 'I' Ellison Heritage Community Centre Local Service Area Establishment Bylaw No. 852, 1999".



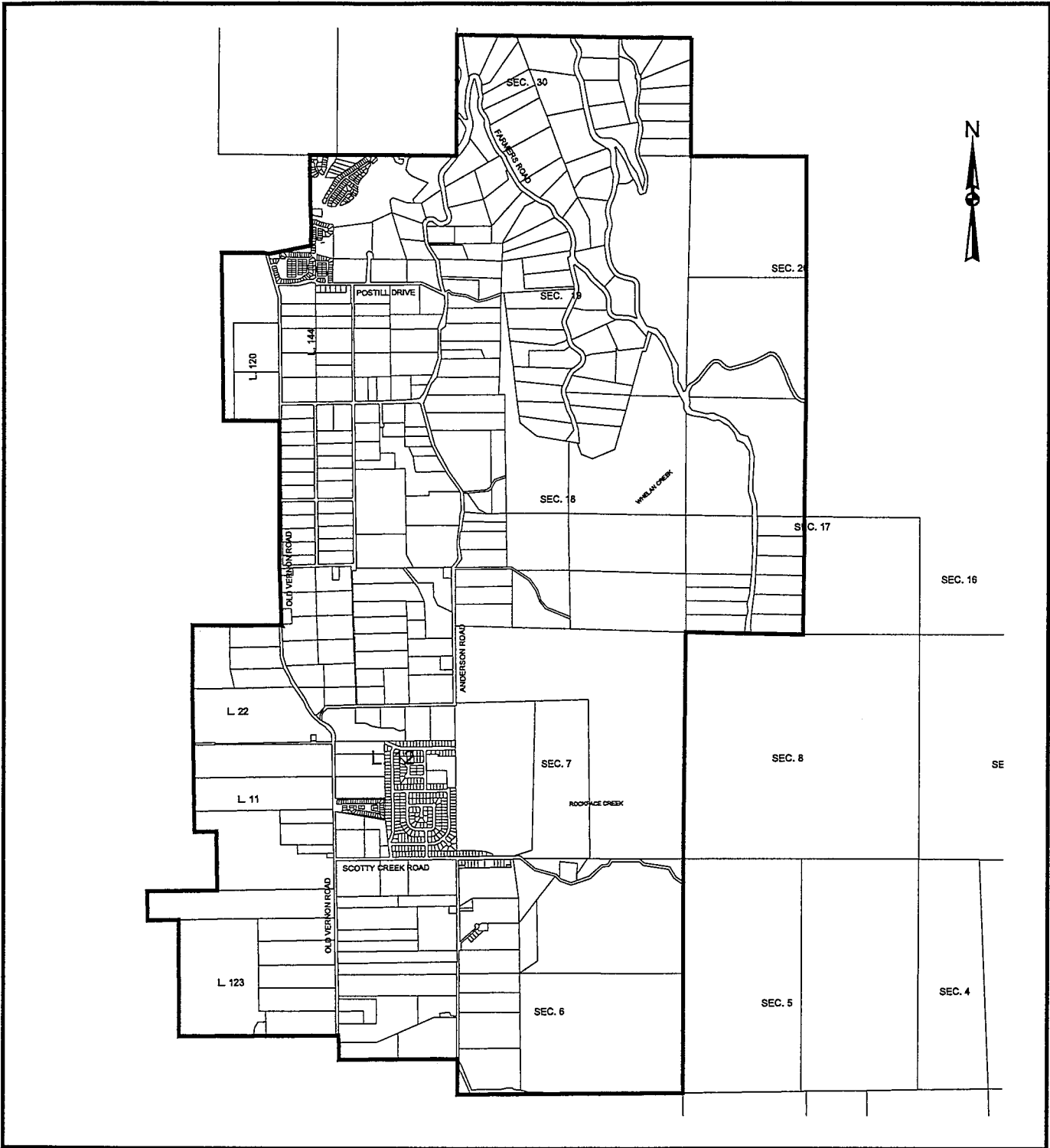
