

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 858

Being a bylaw to amend a local service area.

WHEREAS the Regional Board of the Regional District of Central Okanagan established by Bylaw No. 683, and amended by bylaw no. 803, cited as the "Regional District of Central Okanagan Sewer System Local Service Area 303 - Mount Boucherie Establishment Bylaw No. 683, 1996" a local service area for the purpose of providing sewer service to a portion of Electoral Area 'G';

AND WHEREAS pursuant to Section 812 of the Municipal Act, the Regional Board has obtained a valid petition for the service;

AND WHEREAS it is deemed necessary to amend Bylaw No. 683, as amended by bylaw no. 803, to allow for cost recovery by the imposition of a parcel tax in order to provide the property owners with an opportunity to commute their share of the costs.

AND WHEREAS the Director of Electoral Area 'G' has consented in writing to the adoption of this Bylaw;


NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

- 1 (a) Section 3(a) is repealed and the following substituted:
 - 3 (a) The requisition of money under Section 823 to be collected by a parcel tax to be imposed in the manner provided by Section 825(2).
- (b) Section 3 is amended to include:
 - 3 (c) The parcel tax for each parcel or group of parcels shall be based on the assessed land value of each parcel or group of parcels as of November 30, 1998. The parcel tax shall be established by dividing each parcels' assessed land value by the total assessed land value of all parcels located within the local service area and multiplying the resulting quotient by the total requisition amount.
2. This Bylaw may be cited as the "Regional District of Central Okanagan Sewer System Local Service Area 303 - Mount Boucherie Amending Bylaw No. 858, 1999".




