

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 867

Being a bylaw to amend a local service area.

WHEREAS the Regional Board of the Regional District of Central Okanagan established Bylaw No.651, 1995, and as amended by Bylaw No. 762, 1998, cited as the "Regional District of Central Okanagan Westside Street Lighting Local Service Area Establishment Bylaw No. 651, 1995", a local service area for the provision of the operation and maintenance of streetlighting within a portion of Electoral Area "G" and a portion of Electoral Area "Westbank";

AND WHEREAS the Regional Board of the Regional District of Central Okanagan has been petitioned to add parcels of land to the Westside Streetlighting Local Service Area to include:

Lot A,	Plan 40417	D.L. 1117	O.D.Y.D;	and
Lots 2 - 5,	Plan KAP 50056	D.L. 507	O.D.Y.D;	and
Lots 1 - 10,	Plan KAS 1609	D.L. 507	O.D.Y.D;	and
Lots 1 - 4,	Plan KAS 1781	D.L. 507	O.D.Y.D;	and
Lots 1 - 5,	Plan 29377	D.L. 506	O.D.Y.D;	and
Lot A,	Plan 32186	D.L. 1119	O.D.Y.D;	

AND WHEREAS the Directors of Electoral Areas "G" and "Westbank" have consented in writing to the adoption of this Bylaw:

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN in open meeting assembled, enacts as follows:

1. The boundaries of the Streetlighting Local Service Area created under Bylaw No. 651, as amended by Bylaw No. 762, cited as the "Regional District of Central Okanagan Westside Street Lighting Local Service Area Establishment Bylaw No. 651, 1995", are hereby extended to include:

Lot A,	Plan 40417	D.L. 1117	O.D.Y.D;	and
Lots 2 - 5,	Plan KAP 50056	D.L. 507	O.D.Y.D;	and
Lots 1 - 10,	Plan KAS 1609	D.L. 507	O.D.Y.D;	and
Lots 1 - 4,	Plan KAS 1781	D.L. 507	O.D.Y.D;	and
Lots 1 - 5,	Plan 29377	D.L. 506	O.D.Y.D;	and
Lot A,	Plan 32186	D.L. 1119	O.D.Y.D;	

shown as the shaded area on Schedule 'A' attached hereto and forming part of the Bylaw.

2. The participants in the service are a portion of Electoral Area "G" and a portion of Electoral Area "Westbank".

3. This Bylaw may be cited as the "Regional District of Central Okanagan Westside Streetlighting Local Service Area Amending Bylaw No. 867, 2000".


