

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 868

A bylaw to establish a local service within a portion of Electoral Area 'Westbank' to provide for Ornamental Street Lighting to the Shamrock Drive / Ensign Way area.

WHEREAS a regional district may, by bylaw, establish and operate a local service under the provisions of Part 24 of the Municipal Act;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to establish a local service for the purpose of providing ornamental street lighting within a portion of Electoral Area 'Westbank';

AND WHEREAS pursuant to Section 812 of the Municipal Act, the Regional District of Central Okanagan has obtained a valid petition for the service;

AND WHEREAS the Director of Electoral Area 'Westbank' has consented in writing to the adoption of this Bylaw;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to provide owners of properties within the proposed Shamrock Drive / Ensign Way Street Lighting Local Service Area the opportunity to pay the total per parcel capital cost prior to preparation of the first annual requisition for the service;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. The Regional District hereby establishes within Electoral Area 'Westbank', as shown outlined on Schedule 'A' attached to and forming part of this Bylaw, a local service for the purpose of providing ornamental street lighting and to be known as the "Shamrock Drive / Ensign Way Street Lighting Local Service Area".
2. The participants in the local service, established under Section 1, is a portion of Electoral Area 'Westbank' and the boundary of the service is the boundary outlined on Schedule "A".
3. The annual costs for the service established in Section 1 shall be recovered by:
 - a) The requisition of money under Section 823, to be collected by a parcel tax imposed in the manner provided by Section 825 (2) of the Municipal Act.
 - b) The imposition of fees and other charges that may be set by separate bylaw for the purpose of recovering these costs.

- 4. The Regional Board may, by separate bylaw, provide that the parcel tax imposition under Section 825 (2) may be commuted for payment in cash under the terms and conditions set under that bylaw.
- 5. The maximum amount that may be requisitioned annually under Section 816 (1) (b) for costs of the service shall be \$3,500.00.
- 6. This Bylaw may be cited as the "Regional District of Central Okanagan Shamrock Drive / Ensign Way Street Lighting Local Service Area Establishment Bylaw No. 868, 2000.


