

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 891

Being a bylaw to provide for the imposition of an Annual Debt Servicing Fee to service the debt of Sanitary Sewer Local Service Area 604 – Lakeview.

WHEREAS the Regional Board of the Regional District of Central Okanagan has created Sanitary Sewer Local Service Area 604 - Lakeview and has determined that, in addition to a parcel tax to be imposed by separate bylaw pursuant to Section 816(1)(b) of the Local Government Act, recovery of the annual costs for the service must be by the imposition of fees and other charges established by bylaw pursuant to Section 816(1)(c) of the Local Government Act;

AND WHEREAS in establishing fees and charges under Section 816(1)(c) of the Act, the bylaw that imposes the fees and charges may set different fees and charges on different classes of property or types of land use as specified in the bylaw;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to ensure that all participants in the Local Service Area are treated in a fair, reasonable and equitable manner;

AND WHEREAS the fees and other charges established pursuant to Section 816(1)(c) of the Act shall be established by bylaw;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. There is hereby imposed and levied an annual Debt Servicing Fee against the owners or occupiers of real property located in Local Service Area 604 – Lakeview in the amounts applicable to the classes of property and types of land use as stipulated in Schedule ‘A’ attached to and forming part of this Bylaw.
2. The annual Debt Servicing Fee, shall be due and payable, within 30 days of billing, at the office of the Regional District of Central Okanagan, 1450 KLO Road, Kelowna, B.C., V1W 3Z4, Canada.
3. Any annual Debt Servicing Fee remaining unpaid on the thirty first day of December shall be deemed to be taxes in arrears, in respect of the property subject to the fee, and shall be immediately entered on the real property tax roll by the Collector as taxes in arrears.
4. The maximum term for which an annual Debt Servicing Fee may be applied to a property shall not exceed twenty (20) years.




