

**REGIONAL DISTRICT OF CENTRAL OKANAGAN**

**BYLAW NO. 892**

---

Being a bylaw to amend a local service area.

---

WHEREAS the Regional Board of the Regional District of Central Okanagan established by Bylaw No. 825 cited as the "Regional District of Central Okanagan Sewer System Local Service Area 503 - Gellatly Establishment Bylaw No. 825, 1999" a local service area for the purpose of providing sewer service to a portion of Electoral Area "Westbank";

AND WHEREAS the Regional Board deems it necessary to amend the said local service area to exclude:

Lot 1, Plan 18964, DL 487  
Lot A, Plan 33621, DL 487  
Lot A, Plan 18381, DL 487

AND WHEREAS the Regional Board of the Regional District of Central Okanagan waives the assent of the electorate in accordance with Part 3, Section 18, Subsection (9) of the Waste Management Act;

AND WHEREAS the Director of Electoral Area "Westbank" has consented in writing to the adoption of this Bylaw;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

- 1(a) The boundaries, as established by Bylaw No. 825, 1999 the Regional District of Central Okanagan Area 503 - Gellatly Sanitary Sewer System, are hereby amended to exclude:

Lot 1, Plan 18964, DL 487  
Lot A, Plan 33621, DL 487  
Lot A, Plan 18381, DL 487

shown as the shaded area on Schedule "A" attached hereto and forming part of the Bylaw.

2. This Bylaw may be cited as the "Regional District of Central Okanagan Sewer System Local Service Area 503 - Gellatly Amending Bylaw No. 892, 2000".


