BYLAW NO. 899

Being a bylaw to amend "The Regional District of Central Okanagan North Westside Road Fire Protection Local Service Area Establishment and Expansion Bylaw No. 548, 1993" to provide for a Medical First Responder program.

---

WHEREAS Bylaw No. 548 being "The Regional District of Central Okanagan North Westside Road Fire Protection Local Service Area Establishment and Expansion Bylaw No. 548, 1993" was adopted April 5, 1993;

AND WHEREAS it is desirable to provide that a Medical First Responder service be included in the powers permitted in the North Westside Fire Protection Local Service Area;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

1. The Regional District of Central Okanagan North Westside Road Fire Protection Local Service Area Establishment and Expansion Bylaw No. 548, 1993, is hereby amended as follows:
  - a) Section 5 is amended by adding after the words (c) disaster planning, the following:
    - (d) medical first responder program.
2. This bylaw may be cited as "The Regional District of Central Okanagan North Westside Road Fire Protection Local Service Area Establishment and Expansion Amendment Bylaw No. 899, 2000."


