

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 903

Being a bylaw to provide for the commuting of parcel taxes for the improvement of a street within the Regional District of Central Okanagan Works & Services Service Area 201 - Westbank.

WHEREAS a service area for the improvement of a road has been established by the Regional District of Central Okanagan by Bylaw No. 896, cited as the "Regional District of Central Okanagan Works & Services Service Area 201 - Westbank Establishment Bylaw No. 897, 2000";

AND WHEREAS Bylaw No. 896 specifies that the annual cost of providing this service shall be recovered by the requisition of money under Section 806 of the Local Government Act, to be collected by a parcel tax to be imposed in the manner provided by Section 806.1(1)(b) and the imposition of fees and other charges;

AND WHEREAS Bylaw No. 896 further specifies that the Regional Board of the Regional District of Central Okanagan may by separate bylaw provide that the parcel tax imposition under Section 806.1(1)(b) may be commuted for payment in cash under the terms and conditions of that Bylaw;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

- 1) That the parcel tax imposed under Section 806.1(1)(b) of the Local Government Act, as enacted by the Regional District of Central Okanagan Works & Services Service Area 201 - Westbank Establishment Bylaw No. 896, 2000, may be commuted for payment in cash pursuant to Section 806.1(2) under the following terms and conditions:

Any person, whose parcel is subject to being specifically charged a parcel tax pursuant to Bylaw No. 897 of the Regional District of Central Okanagan, may commute the parcel tax imposed thereon, by making a one time payment in cash equal to the portion of the cost of providing the sewer service assessed upon the parcel within 45 days of receipt of written instructions from the Regional District of Central Okanagan.


