**BYLAW NO. 905**

Being a bylaw to amend a service area.

---

WHEREAS the Regional Board of the Regional District of Central Okanagan established by Bylaw No. 416 cited as the "Regional District of Central Okanagan Wilson's Landing Fire Protection Local Service Area Establishment Bylaw No. 416, 1990", a service for the purpose of providing fire protection to a portion of Electoral Area 'G';

AND WHEREAS requests have been received by the Regional District of Central Okanagan to extend the Wilson's Landing Fire Protection Service Area boundary to include additional parcels of land within a portion of Electoral Area 'G';

AND WHEREAS the Regional Board deems it necessary to expand the said service area to include the areas shown as the shaded areas on Schedule "A" attached hereto;

AND WHEREAS pursuant to section 797.4 of the Local Government Act, the Regional District of Central Okanagan has obtained a valid petition for the service;

AND WHEREAS the Director of Electoral Area 'G' has consented in writing to the adoption of this Bylaw;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

1. The boundaries of the Wilson's Landing Fire Protection Local Service Area Establishment Bylaw No. 416, 1990, are hereby amended to include such properties as outlined in Schedule "A" attached hereto and forming part of this Bylaw.
2. This Bylaw may be cited as the "Regional District of Central Okanagan Wilson's Landing Fire Protection Service Area Amendment Bylaw No. 905, 2000".

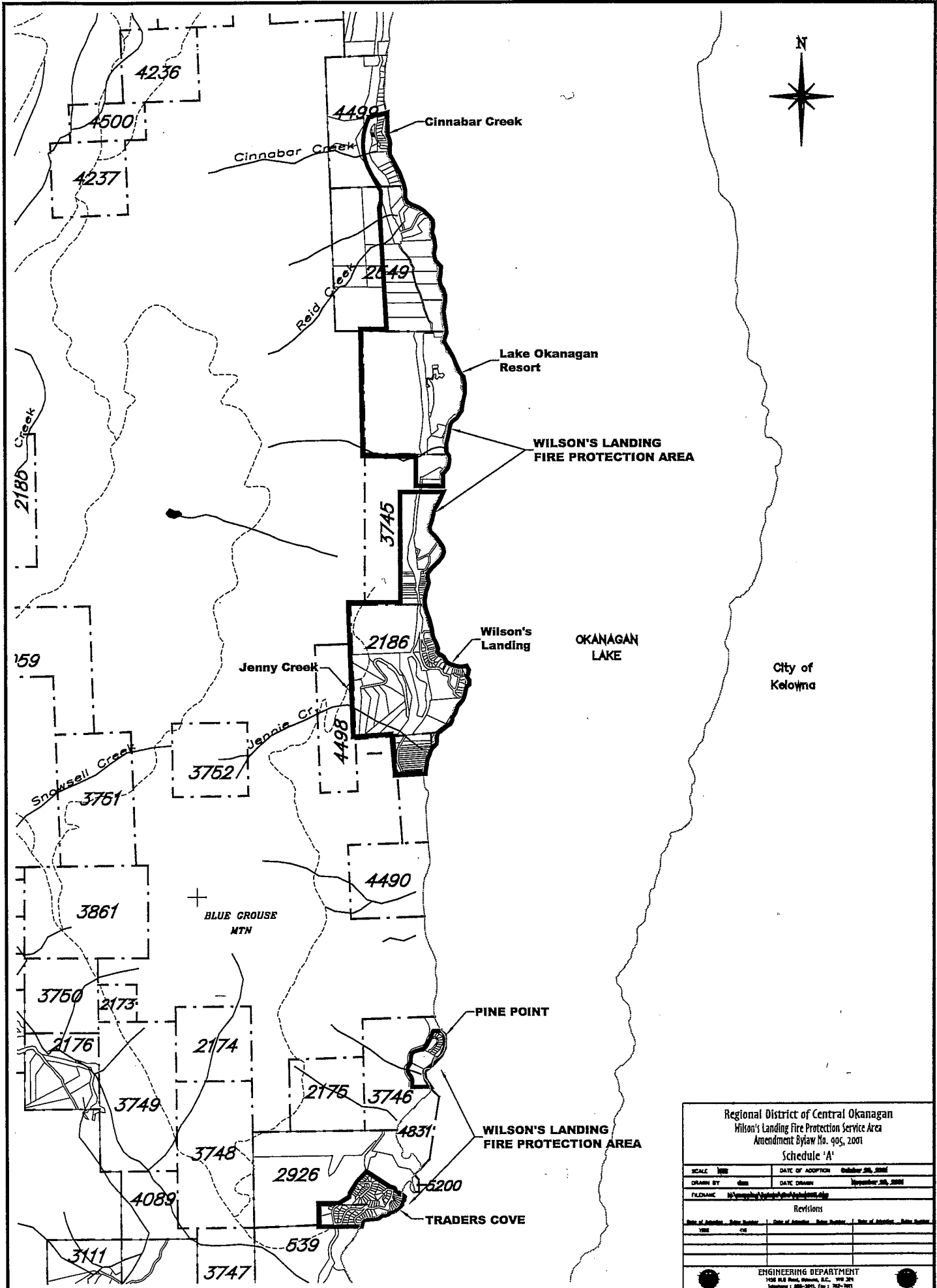




