BYLAW NO. 938

Being a bylaw to amend the Regional District of Central Okanagan "Ellison Fire Protection Local Service Establishment Bylaw No. 418, 1990" to provide for a Medical First Responder program.

WHEREAS Bylaw No. 418 being the Regional District of Central Okanagan "Ellison Fire Protection Local Service Establishment Bylaw No. 418, 1990" was adopted March 5, 1990 and amended by Bylaw Nos. 503, 542, 778 and 798;

AND WHEREAS it is desirable to provide that a Medical First Responder service be included in the powers permitted in the Ellison Fire Protection Service Area;


NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

1. The Regional District of Central Okanagan Ellison Fire Protection Local Service Establishment Bylaw No. 418, 1990, is hereby amended as follows:
 - a) Section 4 is amended by adding after the words (c) disaster planning, the following:
 - (d) medical first responder program.
2. This bylaw may be cited as "The Regional District of Central Okanagan Ellison Fire Protection Service Area Amendment Bylaw No. 938, 2001."


