A bylaw to amend the Westbank Sewer System User Rates Codes.

---

WHEREAS the Regional Board of the Regional District of Central Okanagan deems it necessary to amend the Regional District of Central Okanagan Westbank Sewer System Rates Bylaw No. 399, as amended by Bylaws Nos. 450, 499, 530, and 927.

AND WHEREAS the Regional Board deems it advisable to amend the said bylaw;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled enacts as follows:

1. The Regional District of Central Okanagan Westside Regional Sewer System Fees & Charges Bylaw No. 927, 2001 is hereby amended as follows:

1(a). by adding to SECTION 4 – FEES & CHARGES:

“4.06 Dept Servicing Fee

Where a Dept Servicing Fee applies, the fee shall be established and collected by separate bylaw.”

1(b). by deleting Schedule “A” in its entirety and replacing it with Schedule “A” attached hereto.


