A bylaw to amend the Regional District of Central Okanagan Westside Community Parks Local Service Establishment Bylaw No. 549, 1993

---

WHEREAS the Regional District of Central Okanagan Westside Community Parks Local Service Establishment Bylaw No. 549, 1993 was adopted by the Regional Board on the 5th day of April, 1993.

AND WHEREAS the requisition limit of Bylaw No. 549 was amended by Regional District of Central Okanagan Westside Community Parks Local Service Establishment Amendment Bylaw No. 782, 1998 and Regional District of Central Okanagan Westside Community Parks Local Service Establishment Amendment Bylaw No. 834, 1999;

AND WHEREAS the Regional Board deems it advisable to further amend the requisition limit of the said Bylaw;

AND WHEREAS the Director of Electoral Area 'G' and the Director of Electoral Area 'Westbank', being the participating members of this local service area, have consented to amending the requisition rate;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled enacts as follows;

1. That the Regional District of Central Okanagan Westside Community Parks Local Service Establishment Bylaw No. 549, 1993 be amended by repealing and replacing Clause 5 with the following:

5. **Requisition Limit**

The maximum amount of money that may be requisitioned annually under Section 806 (1) of the Local Government Act for the service provided under Section 1, will not exceed \$0.57 per \$1,000 of net taxable value of land and improvements for Regional District purposes, within the service area.

2. This bylaw may be cited as the Regional District of Central Okanagan Westside Community Parks Local Service Establishment Amendment Bylaw No. 959, 2002.






