

REGIONAL DISTRICT OF CENTRAL OKANAGAN
BYLAW NO. 960

A bylaw to establish a service within a portion of Electoral Area 'G' to provide for sewer service, which includes design, construction, and operation of a sanitary sewer collection system to the Anders Road area.

WHEREAS a regional district may, by bylaw, establish and operate a service under the provisions of Part 24 of the Local Government Act;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to establish a service for the purpose of providing sewer service, which includes design, construction, and operation of a sanitary sewer collection system, to a portion of Electoral Area 'G';

AND WHEREAS the Regional District of Central Okanagan has an approved Liquid Waste Management Plan;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan waives the assent of the electorate in accordance with Part 3, Section 18, Subsection (9)(d) of the Waste Management Act;

AND WHEREAS the Director of Electoral Area 'G' has consented to the establishment of the service area;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. The Regional District hereby establishes within Electoral Area 'G' a service for the purpose of providing sewer service, which includes design, construction, and operation of a sanitary sewer collection system, and to be known as the "Sewer System Service Area 607 – Lakeview".
2. The participants in the service, established under Section 1, are portions of Electoral Area 'G' as shown outlined on Schedule "A" attached hereto and forming part of the Bylaw.
3. The annual costs for the service established in Section 1 shall be recovered by:
 - a) The requisition of money under Section 806 to be collected by a parcel tax imposed in the manner provided by Section 806.1(1)(b).
 - b) The imposition of fees and other charges that may be set by separate bylaw for the purpose of recovering these costs.
4. The maximum amount that may be requisitioned annually under Section 803(1)(b) for the service shall be \$ 20,000.
5. The Regional Board may, by separate bylaw, provide that the parcel tax imposition under Section 806.1(1)(b) may be commuted for payment in cash under the terms and conditions set under that bylaw.

6. This bylaw may be cited as the "Regional District of Central Okanagan Sewer System Service Area 607 - Lakeview Establishment Bylaw No. 960, 2002.


