REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 963

---

Being a bylaw to authorize the borrowing of Nine Hundred Ninety Seven Thousand (\$997,000.00) for the purpose of providing capital financing for acquisition of land for Westside Community Parks purposes.

---

WHEREAS the Regional District of Central Okanagan has established by Bylaw No. 549, 1993, and amendments thereto; a local service for the purpose of providing Westside Community Parks within Electoral Area 'G' and Electoral Area 'Westbank';

AND WHEREAS pursuant to Sections 831(1) and 334.4 [2 (b)] of the Local Government Act the Regional Board may borrow monies for capital purposes for a period not to exceed five years with the approval of the Inspector of Municipalities;

AND WHEREAS the monies to be borrowed are for the acquisition of land for Westside Community Parks purposes;

AND WHEREAS the total amount of debenture debt of the Regional District authorized under:

- (a) Section 830 of the Local Government Act in respect of short term capital borrowing is \$13,860;
- (b) Section 831 of the Local Government Act in respect of loan authorization bylaws is \$19,350,022
- (c) Section 831.1 of the Local Government Act in respect of loan authorization bylaws is Nil;
- (d) Section 835 of the Local Government Act in respect of the financing of municipal undertakings is \$55,233,460;

AND WHEREAS the amount of existing outstanding debenture debt of the Regional District authorized under:

- (a) Section 830 of the Local Government Act in respect of short term capital borrowing is \$2,763;
- (b) Section 831 of the Local Government Act in respect of loan authorization bylaws is \$9,681,134;
- (c) Section 831.1 of the Local Government Act in respect of loan authorization bylaws is Nil;
- (d) Section 835 of the Local Government Act in respect of the financing of municipal undertakings is \$47,350,920;

AND WHEREAS the amount of debenture debt that is authorized but is not issued under:

- (a) Section 830 of the Local Government Act in respect of short term capital borrowing is \$11,097;
- (b) Section 831 of the Local Government Act in respect of loan authorization bylaws is 9,668,888;
- (c) Section 831.1 of the Local Government Act in respect of loan authorization bylaws is Nil;
- (d) Section 835 of the Local Government Act in respect of the financing of Municipal undertakings is \$7,882,540;

AND WHEREAS the amount of principal or interest that, as of the date of the adoption of this bylaw, is in arrears on debt created under Sections 830, 831, 831.1 and 835 of the Local Government Act is Nil;

AND WHEREAS the authority to borrow under this bylaw expires five years from the date on which this bylaw is adopted;

AND WHEREAS the maximum term for which a debenture may be issued to secure the debt created by this bylaw is for a term not to exceed 5 years;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

**Loan Authorization**

1. The Regional Board is hereby authorized and empowered for the local service for Westside Community Parks under Bylaw No. 549, 1993, and amendments thereto;
  - a) To borrow on the credit of the Regional District a sum not exceeding Nine Hundred and Ninety Seven Thousand Dollars (\$997,000.00) for the purpose of providing capital financing for the acquisition of land Westside Community Parks purposes;
  - b) To acquire all such real property, easements, rights-of-way, licenses, or authorities as may be requisite or desirable for or in connection with the establishment and operation of Westside Community Parks.
2. This bylaw may be cited as "Regional District of Central Okanagan Westside Community Parks Loan Authorization Bylaw No. 963, 2002".



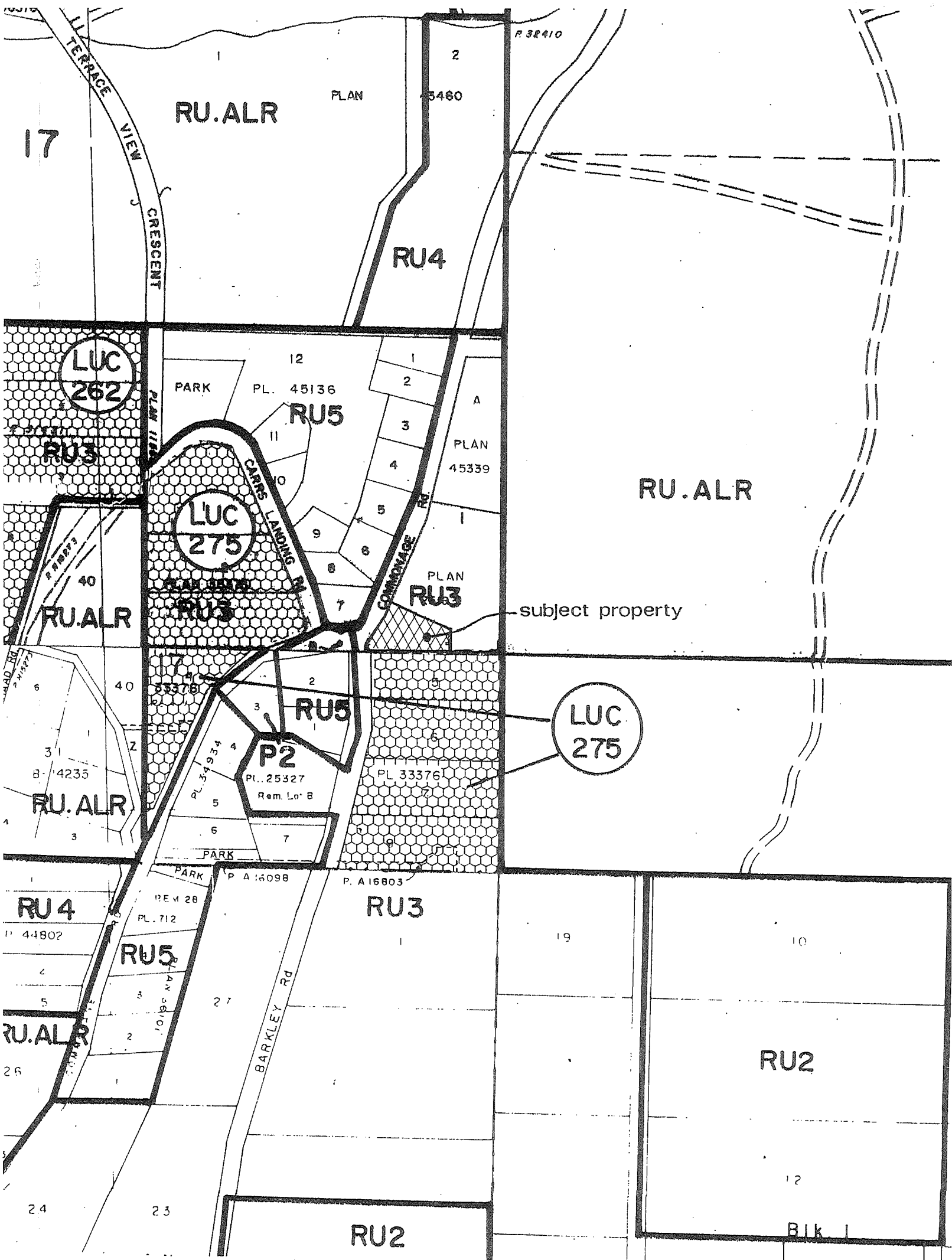


