Being a bylaw to amend the Regional District of Central Okanagan Handi-Dart Transit Local Service Area Establishment Bylaw No. 419, 1990.

WHEREAS the Regional District of Central Okanagan has adopted the "Regional District of Central Okanagan Handi-Dart Transit Local Service Area Establishment Bylaw No. 419, 1990";

AND WHEREAS it is deemed necessary to amend the said local service area to delete the Corporation of the District of Peachland as a participating member;

AND WHEREAS the Council of the Corporation of the District of Peachland and the Directors of Electoral Areas Westbank and "G" have consented in writing to the adoption of this Bylaw;

NOW THEREFORE the Regional District of Central Okanagan, in open meeting assembled, enacts as follows:

1. That clause 1 be amended to remove the District of Peachland as a Municipal participating area.
2. This Bylaw may be cited as Regional District of Central Okanagan Handi-Dart Transit Local Service Area Establishment Amendment Bylaw No. 965, 2002.


