BYLAW NO. 1003

A bylaw to amend the Regional District of Central Okanagan Water Utility User and Maintenance Fee Bylaw.

WHEREAS the Regional Board of the Regional District of Central Okanagan adopted the "Regional District of Central Okanagan Water Utility User and Maintenance Fee Bylaw No. 664, 1996" as amended by Bylaw Nos. 709, 734, 843 and 989, a bylaw to provide for the imposition of fees and charges against the owner of any parcel which is connected to a Regional District of Central Okanagan water system;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan deems it necessary to amend the bylaw to allow for the imposition of fees and charges to all parcels located within a Regional District of Central Okanagan water system service area.


NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled enacts as follows:

The Regional District of Central Okanagan Water Utility User and Maintenance Fee Bylaw No. 664, 1996, as amended by Bylaw Nos. 709, 734, 843 and 989, is hereby amended as follows:

- (a) by amending Section 6 by deleting the date "thirty-first of December" and substituting therefore the date "fifteenth of December".
- (b) by deleting Schedule "A" in its entirety and replacing it with Schedule "A" attached hereto

2. This bylaw may be cited as the "Regional District of Central Okanagan Water Utility and Maintenance Fee Amendment Bylaw No. 1003, 2003".

Pritchard Drive	\$ 170.00
Falconridge	\$ 300.00
West Kelowna	\$ 250.00
Trepanier (Dietrich)	\$ 800.00
Westshores	\$ 200.00
Sunset Ranch	\$ 216.00

Water System	Annual Maintenance Fee Per Parcel
West Kelowna (unimproved parcels)	\$ 60.00
Westshores (all parcels)	\$ 130.00
Sunset Ranch (parcels > 0.25 hectares)	\$ 1,800.00 maximum

Billing will coincide with any other utility charges being levied by the Regional District on a quarterly or semi-annual basis.
