**REGIONAL DISTRICT OF CENTRAL OKANAGAN**

**BYLAW NO. 1015**

---

A bylaw to establish a service within a portion of Ellison/Joe Rich Electoral Area to provide for renovation, construction and on-going operation for a community hall on the Joe Rich Community Hall/Fire Hall site.

---

WHEREAS a regional district may, by bylaw, establish and operate a service under the provisions of Part 24 of the *Local Government Act*;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to establish a service in a portion of Ellison/Joe Rich Electoral Area for the purpose of renovation, construction and operation for a community hall on the Joe Rich Community Hall/Fire Hall site;

AND WHEREAS pursuant to section 801(3) of the *Local Government Act*, a regional district may obtain approval of the electors for an establishing bylaw, by counter petition opportunity in accordance with section 801.3;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. The Regional District hereby establishes within a portion of the Ellison/Joe Rich Electoral Area, a service for the purpose of renovation, construction and ongoing operation for a community hall on the Joe Rich Community Hall/Fire Hall site.
2. The boundaries of the service area established under Section 1, are that portion of Ellison/Joe Rich Electoral Area shown outlined on Schedule "A" attached hereto and forming part of the Bylaw.
3. Pursuant to Section 803(1)(a) of the *Local Government Act*, the annual costs for the service established in Section 1 shall be recovered by:
  - a) The requisition of money under Section 806 to be collected by a property value tax imposed in the manner provided by Section 806.1(1).
  - b) The imposition of fees and other charges that may be set by separate bylaw for the purpose of recovering these costs.
4. The maximum amount that may be requisitioned annually under Section 806 of the *Local Government Act* for the service shall not exceed \$0.50 per \$1000 of net taxable value of land and improvements for Regional Hospital purposes, within the service area.
5. This bylaw may be cited as the "Regional District of Central Okanagan Joe Rich Community Hall Service Area Establishment Bylaw No. 1015, 2003.
