

**Regional District of Central Okanagan**

**Bylaw No. 1027**

---

A bylaw to establish a service in the City of Kelowna, District of Peachland and Electoral Area Westside to provide for the regulation of specific animals (Prohibited Animals).

---

WHEREAS a Regional District may, by bylaw establish a service under the provisions of the Local Government Act.

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to establish a service for the purpose of regulating specific animals (Prohibited Animals);

AND WHEREAS the Directors of Electoral Area Westside, the City of Kelowna and the Corporation of the District of Peachland have consented to the establishment of the service of "Prohibited Animal Control" in the whole of their areas;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. The Regional District of Central Okanagan hereby establishes within Electoral Area Westside, the City of Kelowna and the Corporation of the District of Peachland a service for regulating specific animals to be known as the "Prohibited Animal Control Service".
2. The participants of the service area, established under Section 1 are all of Electoral Area Westside, the City of Kelowna, and the Corporation of the District of Peachland.
3. The annual costs for the service established in Section 1 shall be recovered by:
  - a) The imposition of a property value tax, and
  - b) The imposition of fees and charges.

This bylaw may be cited as the "Regional District of Central Okanagan Prohibited Animal Control Service Area Establishment Bylaw No. 1027.





**Re: Prohibited Animal Bylaw**

I am please to confirm that the following resolution was adopted by Kelowna City Council at their Regular Meeting of Monday, July 21, 2003:
