

**REGIONAL DISTRICT OF CENTRAL OKANAGAN**

**BYLAW NO. 1036**

---

Being a bylaw to authorize temporary borrowing pending the sale of debentures.

---

WHEREAS it is provided by Section 335.2 of the Local Government Act that the Regional Board may, where it has adopted a loan authorization bylaw, without further assent or approvals, borrow temporarily from any person under the conditions therein set out;

WHEREAS the Regional District of Central Okanagan has adopted Bylaw No. 1031, cited as the "Regional District of Central Okanagan Sewer System Service Area 202 – Westbank Loan Authorization Bylaw No. 1031, 2003" authorizing the design and construction of sewer works in the amount of Forty Eight Thousand, Eight Hundred and Twenty Five Dollars (\$48,825.00).


NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

**Temporary Borrowing**

- 1 The Regional Board is hereby authorized and empowered in conjunction with the establishment of the Sewer System Service Area 202 – Westbank Loan Authorization Bylaw No. 1031 to borrow from the Imperial Bank of Commerce, Main Branch, Kelowna, B.C., an amount or amounts not exceeding the sum of Forty Eight Thousand, Eight Hundred and Twenty Five Dollars (\$48,825.00), as the same may be required, at an interest rate not exceeding that approved by the Inspector of Municipalities.
2. The form of obligation to be given as acknowledgement of the liability shall be a Promissory Note or Notes bearing the corporate seal of the Regional District of Central Okanagan and signed by the Chairman and the Treasurer.
3. The money so borrowed shall be used solely for the purpose set out in said Bylaw No. 1031.
4. The proceeds from the sale of debentures or so much thereof as may be necessary shall be used to repay the money borrowed.
5. This bylaw may be cited as "Regional District of Central Okanagan Sewer System Service Area 202 – Westbank Temporary Borrowing Bylaw No. 1036, 2003.
