BYLAW NO. 1131

Being a bylaw to amend the Regional District of Central Okanagan Joe Rich Fire Protection Local Service Establishment Bylaw No. 404, 1989 to provide for a Medical First Responder program.

WHEREAS Bylaw No. 404 being the Regional District of Central Okanagan Joe Rich Fire Protection Local Service Establishment Bylaw No. 404, 1989, was adopted January 8th, 1990;

AND WHEREAS it is desirable to provide that a Medical First Responder service be included in the powers permitted in the Joe Rich Fire Protection Local Service Area;

AND WHEREAS the Director of the Central Okanagan East Electoral Area has consented to the service;

NOW THEREFORE THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. The Regional District of Central Okanagan Joe Rich Fire Protection Local Service Establishment Bylaw No. 404, 1989, as amended, is hereby further amended by repealing and replacing Section 1, subsection a) with the following:
 - a) to carry out all fire protection activities within the service area including, but not limited to:
 - I. Fire suppression and prevention
 - II. Rescue
 - III. Disaster planning
 - IV. Medical First Responder Program

2. This Bylaw may be cited as the "Regional District of Central Okanagan Joe Rich Fire Protection Local Service Amendment Bylaw No. 1131, 2005".


