

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 1264

Being a bylaw to amend the Regional District of Central Okanagan Urban Transit Local Service Area Establishment Bylaw No. 376, 1990

WHEREAS the Regional District of Central Okanagan has adopted the "Regional District of Central Okanagan Urban Transit Local Service Area Establishment Bylaw No. 376, 1990," and as amended by Bylaw No. 722, Bylaw No. 765, Bylaw No. 935 and Bylaw No. 966;

AND WHEREAS upon the incorporation of the District of West Kelowna, the service of transit was not transferred to the municipality but remained as a service of the Regional District;

AND WHEREAS the District of West Kelowna has expressed a desire to assume responsibility for Urban Transit Services within their boundaries and the Regional Board has agreed to this;

AND WHEREAS the District of Peachland has confirmed their desire to remain within the Urban Transit Local Service Area Establishment Bylaw;

AND WHEREAS it is deemed necessary to amend the said local service area to delete the District of West Kelowna (formerly known as a portion of Electoral Areas 'G' and 'H') and redefine, as a result of incorporation of the District of West Kelowna, the new boundary for the Central Okanagan West Electoral Area to include only IR#9 and IR#10, as a participating member;

AND WHEREAS the Council of the District of West Kelowna, the Council of the District of Peachland and the Director of Central Okanagan West Electoral Area have consented in writing to the adoption of this Bylaw;

NOW THEREFORE the Regional District of Central Okanagan, in open meeting assembled, enacts as follows:

1. That clause 1 be amended to remove the District of West Kelowna (formerly known as a portion of Electoral Area H and Electoral Area G) as a municipal participating area, and update the new boundary, as a result of incorporation of the District of West Kelowna, for the participating area portion now known as Central Okanagan West Electoral Area, as shown in Schedule C, to include only IR#9 and IR#10.
2. This Bylaw may be cited as Regional District of Central Okanagan Urban Transit Local Service Area Establishment Amendment Bylaw No. 1264, 2009.



The District of West Kelowna has approached BC Transit and the Regional District with a request for more direct involvement in transit. At its June 22, 2009 board meeting the Regional District of Central Okanagan passed a resolution of support in principle subject to some conditions.

BC Transit is in support of the request and would like to establish a West Kelowna MOA/AOA as part of the Kelowna Regional Transit System effective April 1, 2010.

The assignment of local government responsibilities and allocation of costs, currently assigned to the Regional District of Central Okanagan, need to be resolved as well there may be internal documents which will need to be amended for both the municipality and the Regional District. BC Transit is in the process of calculating the revised costs per partner and will assist in the transition of local responsibilities if requested.

Work is underway on the Kelowna Regional Master Plan which will guide the service concept and design discussions for the entire transit system in the future. The establishment of this new AOA does not preclude continued discussions with Okanagan municipalities on new service delivery models for transit.
