BYLAW NO. 1299

Being a bylaw to amend the Regional District of Central Okanagan Ticket Information Utilization Bylaw No. 435

WHEREAS, the Regional District of Central Okanagan adopted the Regional District of Central Okanagan Ticket Information Utilization Bylaw No. 435, 1990, as amended;

AND WHEREAS it is deemed necessary to amend the Ticket Information Utilization Bylaw;

NOW THEREFORE THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. Delete the following Schedules (Schedule 2, Schedule 4, Schedule 5, Schedule 6, Schedule 7, Schedule 8, Schedule 9, Schedule 12, Schedule 13, Schedule 17, Schedule 19; Schedule 20, and Schedule 21) in their entirety

and;

Replace with the new Schedule 2, Schedule 4, Schedule 5, Schedule 6, Schedule 7, Schedule 8, Schedule 9, Schedule 12, Schedule 13, Schedule 17, Schedule 19; Schedule 20, and Schedule 21, attached hereto and forming part of this bylaw.


2. Delete Schedule 18 in its entirety and do not replace.
3. Add the following new Schedules (Schedule 23, Schedule 24, Schedule 25, Schedule 26, Schedule 27, and Schedule 28).
3. This bylaw may be cited for all purposes as the "Regional District of Central Okanagan Ticket Information Utilization Amendment Bylaw No. 1299, 2011".




