

**REGIONAL DISTRICT OF CENTRAL OKANAGAN**

**BYLAW NO. 1309**

Being a bylaw to amend the Regional District of Central Okanagan Water Systems Fees and Regulations Bylaw No. 1268, 2009

WHEREAS the Regional Board of the Regional District of Central Okanagan established Bylaw No. 1268, 2009, as amended by Bylaw Nos. 1301, 2011 and 1307, 2012, a bylaw to establish regulations under which water will be provided and to establish fees and charges which may be imposed against the owner of any parcel located within a Regional District of Central Okanagan water system service area;

AND WHEREAS the Regional Board deems it necessary to amend the said bylaw;

NOW THEREFORE THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. The Regional District of Central Okanagan Water Systems Bylaw No. 1268 is hereby amended by deleting SCHEDULE "B" FEES & CHARGES, Section 4. a), and replacing it with:


